

So does this doll look familiar? She's **Lynn Kopatich's** MIB Little Lady, page 37 in FTLD by **Peggy Casper**. *Note the length of the half-slip and its trim.* Here is the outfit I had always longed to own! It was at the top of my list! Even though Peggy says, "The rose printed chintz still glistens..." I always thought that she was referring to the roses printed on the chintz, and that the background color was white.

In 1999, when **Ellen Lawson** brought her childhood Little Lady to the DC Convention in Albuquerque, "Little Lady and the Engineer," we could all see the "glistening" pink chintz. Ellen's doll came in a trunk with many other outfits, but her LL o/f did not have a half-slip or pantaloons. If you

1950 Little Lady Outfit and Its Two Pinafores

Did you know that this Little Lady pinafore came in two colors? One has a very pale, pink chintz background and the other a white chintz background! *I was very surprised!*

You wonder if this can really be true. Please check out the loopy tag sewn in the same place on the inside of each pinafore.



Peggy Casper shows Lynn Kopatich's MIB Little Lady, page 37, FTLD, 1983. Her caption indicates that the background is pink. However, it is impossible to tell for sure from the FTLD photo what the color is. For many years, it was the only one to turn up, and I never had the opportunity to see it in person. Then in '99 we saw Ellen Lawson's childhood doll with its "glistening pink chintz" pinafore. (See this issue's *chattipatty* for photos.) So far I've documented four such pinafores: L.K., E.L. & my two: three pink, and one white. Anymore?

I found my outfits several years apart and in two different eBay auctions. Both TLs had been *thoroughly* played with. The original pink pinafore TL had her pinafore & taffeta dress, but her beautiful, bright red mannequin hair had bangs cut to the quick, and she had no half-slip

or pantaloons. The white pinafore TL came with pinafore, a different hue of taffeta dress, an extra-long half-slip, no pantaloons and a ghastly replaced wig. I've photographed their Little Lady outfits on different dolls, and I know you are going to appreciate seeing them that way.



It's easy to date this Little Lady outfit to 1950. Check the date on the Little Lady brochure in the set. And, of course, you noticed that the pale blue powder mitt is covered with the same rose bud material as the pinafores.





Taffeta dresses: The older, loopy-tagged Little Lady taffeta dress is quite a bit longer than its pinafore: no velvet trim at the neck and the trim at the bottom is close to the hem. After a transition period, AV dresses were shorter, the trim moved further up and trim added at the neck.

Pantaloons: Doll on left has the usual Little Lady pantaloons with the simplified elastic waistband and higher gather. However, the doll on the right had to borrow a pair from an older outfit. Her pantaloons have nothing to do with the Little Lady o/f, except to show you how the TL Company first made pantaloons before simplifying. Note the tiny, blue

ribbon ties. Furthermore, although you can't see it, the first pantaloons have a waistband and they close with a snap. They were created in 1947, pre-LNFP, and belong to outfit #80: "Terri in long taffeta dress and bonnet trimmed with val lace, pantaloons and full petticoat." Both **Glenda Kitto** and **Dennis Ross** have this o/f MIB on a doll, Glenda's with matching taffeta hat, Dennis' with the long wool coat & hat set. Check out the two Price Lists that precede the LNFP which I gave out at Daisy Chain conventions in 2015 and 2014, along with my presentations on the oldest clothing. You will find this outfit listed in the second list.



Half-slips: Note the unusual eyelet trim and the length of the slip. How interesting that they purposely made one so long! The long half-slip is original to my white chintz pinafore set. It hangs below the hem of dress, exactly as does the slip on the MIB LL of Lynn Kopatich. The shorter slip with identical eyelet came on another Lincoln LL, probably from 1951, a more common one with a large bouquet of flowers & roses on background of pink & blue chintz. Collectors! I'm interested half-slip info! Happy Hunting!!

Magna, Mar-Fan & I&S

What do we know about Magna Enterprises, Mar-Fan, Inc. and I&S Industries? And, how did they become involved with the Terri Lee Doll Co?

Fact #1. In 1959 the many companies involved with Terri Lee were:

Terri Lee Inc., a corporation

Terri Lee Doll Hospital, Inc., a corporation

Terri Lee Fashions, Inc., a corporation

Raysheen Wig Corporation, a corporation

Terri Lee Sales Corporation, a corporation

Connie Lynn Manufacturing Corp., a corporation

Terri Lee of California, a corporation which included Violet Gradwohl and C. Grace Hast as co-partners doing business as Terri Lee of California, a partnership. What a tangled web...

Fact #2. Upon the heels of the Apple Valley fire, Terri Lee of California defaulted on its loan from the Small Business Association which led to the sale of the Terri Lee holdings in Apple Valley and included both real and personal property. The sale involved five separate parcels:

- 1) 3.44 acres with a factory building
- 2) 2.17 acres with an administration building
- 3) 71.13 acres with a dwelling house
- 4) 167.21 acres
- 5) 574 acres

Fortunately for Violet Gradwohl, the proceeds of the auction sale that commenced on April 29 and 30, 1960, covered the outstanding SBA loan and auxiliary creditors. One person acting on behalf of a Joint Venture purchased all five parcels. The final sale price amounted to about 30% of the appraised value and was not

finalized until the end of 1960. While the sale price covered the outstanding SBA loan, it did not provide additional capital to the benefit of Violet Gradwohl. She did, however, retain the molds for several TL products. In her book, Peggy Casper devotes a complete chapter to this sad ending of the independent Apple Valley Terri Lee corporations which is well worth re-reading.

After all of this there was a short lull in hyper-activity for Terri Lee production. But, like a Phoenix bird, we know Terri Lee did rise from the ashes once again. Early in 1961, Vi contracted with **Magna Enterprises, Inc.**, to sell the dolls. This association was short lived. **So far, no Magna box or label has turned up. Please let me know if you have one!**

Within a few months in the August heat of a Los Angeles summer of 1961, Vi had the molds delivered to Fischer Plastics. **There were seven molds in all: for Terri Lee, Connie Lynn, Tiny Terri, sunglasses, clothes hanger and two sets of eye molds (one for Connie Lynn, the other for Tiny Terri).** Once again Vi could begin producing dolls and shipping them to the many “little-mothers” awaiting their delivery.

Mar-Fan Inc. was owned by a **Dr. Albert Ridley** who, by the way, held title to the subsidiary company, Fischer Plastics. **Now, we do find label that says “Mar-Fan”.** But wait! Mar-Fan does not stay in the picture for very long. Within 18 months, at the end of 1962, ownership of Mar-Fan transfers from Dr. Ridley to a Mr. Murray Sands and **the company becomes I&S Industries. Labels are then changed to read I&S Industries. This is the most common Los Angeles Era label.** Have you been able to keep up with all of this? It becomes difficult to sort through since so many changes occurred within a short 2-year time period. Pat Rather has written several articles about the LA Era: 2006 Jan issue and in 2002 the Los Angeles Bus Ride...both are worth reading again.

Vi's interaction with Magna, Mar-Fan and I&S Industries may not have really been in her best interest over the long haul as these three companies were in constant dispute. Vi was pulled into their web because of where her Terri Lee molds resided. The disputes, lawsuits and counter-suits between the named three companies, plus one other additional entity, were in regard to unpaid promissory notes, determining true ownership and alleging a co-conspiracy to defraud. Vi was naturally distraught to say the least. All that she wanted was to continue producing and selling her dolls.

But, Vi was an aggressive and tenacious business person. Her doll company was her life and she was going to push through whatever roadblocks were put in her way in order to continue delivering dolls. After the Apple Valley sale there followed four years of continuous upheaval and involvement in the courts. In the many court documents obtained by Peggy Casper, which are now in my possession, it is stated that since August of 1961 the seven different molds, as mentioned above, were in the hands of Fischer Plastics Inc., a sub-corporation of Mar-Fan, Inc. Because of the many court battles between the

three companies, Magna, Mar-Fan and I&S, it was not until 1965 that Vi regained personal possession of the molds. This is when we assume that she put aside her ambitions for continued production of Terri Lee. The molds were placed in storage and stayed there until the next chapter of litigation began when **Terri Lee Associates** was formed **in 1997**.

Along with all the lawsuits mentioned above we have the additional entity that entered the picture. The business address of 1708 Standard St, Glendale CA. which was the address for Mar-Fan and Fischer Plastic was also the address of Hollywood Doll Manufacturing Company from 1941 – 1956.



Evidently, this doll company is reported to have supplied more dolls to the marketplace than any other doll manufacturer during their time. Perhaps this is why Vi opted to do

business with Mar-Fan as they held the reputation of being in the same location as Hollywood Doll Co. Owners of the Hollywood Doll Co. were Theresa and Domenic Ippolito. Apparently, when the Ippolito's closed the business, they sold the doll manufacturing tools from Hollywood Doll Company to **Dr. Ridley** and held a promissory note regarding that sale. Dr. Ridley then went into default. In 1961 they brought suit for payment against Dr. Ridley and in 1963 won a judgement for the real and personal property located at 1708 Standard St. Glendale, CA. Their suit was just one more layer of complications in the history of Terri Lee. My research thus far has not been able to determine at what time after 1965 they sold the property or if the Ippolito's returned to the doll industry. So, I will close my story of Magna, Mar-Fan and I&S at this point. I am certain there is more to the story which requires additional research.

So, let's recap: In 1960 the Apple Valley properties are sold and close escrow at the end of the same year. Early in 1961 Magna is the sales agent for Terri Lee. (**although there is no proof of this so far in the form of a label**) In August of 1961 Fischer Plastics Inc. (a sub-company of Mar-Fan) has possession of the "molds" and is now manufacturing the dolls for the Connie Lynn Mfg. Co. and using the Mar-Fan label. During 1962 Mar-Fan is sold and becomes I&S Industries. In 1963 the Ippolito's file suit against

Dr. Ridley of Mar-Fan and win a judgement. I&S Industries continue to sell Terri Lee Dolls. By 1965 the Terri Lee molds go into storage.

I don't know how Vi kept her sanity! She fought long and hard to produce a premium product with a quality wardrobe. In the final years, her life became even more complicated as she became involved in many legal entanglements. As avid collectors, we will be searching for more of the story.



Yes, there are more questions and more to the story...

Why was **Magna Enterprises, Inc.** involved for only a four short months?

In research done after I wrote **Part 1** of this article, I located a classified ad in the database of **Newspapers.com** placed by **Magna** for sales reps to take over a variety of territories representing the Terri Lee Doll. OH Boy! Now, we have some interesting information upon which a hypothesis can be established.

Pat Rather and I have been putting together known facts and developing some reasonable theories: Why do we see other dolls dressed in TL clothes during the years 1959-1960? Actually, this fits with the **Magna** time period and could be what filled the gap until the molds were put back into production. It could be that no **Magna** label exists if it was only a sales rep company. Vi may not have been able to use the TL Doll company names because they were tied up in the court case which involved the defaulted Small Business Association loan. She would have needed to create a new legal name. This would also explain why she used the **Connie Lynn Mfg.** name when she began the association with **Mar-Fan**.

It is my belief that after the fire and sale of the Apple Valley properties, Vi was left with the seven (7) Terri Lee molds and some TL clothing. She had no remaining active doll business. She did not have a location for manufacturing, but she did have patterns and clothing that may have been held aside or been in transit from Lincoln to Apple Valley where the dolls were dressed. She received no proceeds from the auction. She needed income!

Perhaps, this is why she contracted with **Magna**. **Magna** was on a commission-only sales contract. Vi had no excess TL dolls, but she did seem to have TL clothing. The advertising supports this theory.

1959 Oct Special Dolls in TL clothing

Between July 1959 through Nov. 1960, we see advertisements in newspapers that reference "**dolls in Terri Lee clothing**." If you recall, the Apple Valley auction was April 1959 and did not finalize until Dec 1959. All of the doll stores across the country were without a shipment from Terri Lee for quite some time.

As a result, dealers were selling from on-hand inventory. One letter to Vi from a loyal dealer anxiously awaiting news of the upcoming Terri Lee situation, states that due to the lack of Terri Lee sponsored advertising, sales had fallen substantially with only three (3) Terri's having been sold during the holiday season.

Knowing that the doll market needed continued awareness of Terri Lee Dolls, Vi did the only thing she could. She authorized other dolls to be dressed in Terri Lee clothing. All of the advertising between mid-1959 until the association with Mar-Fan supports this. Vi was strapped for business capital and with her savvy; she created a new outlet for sales until she could go once again in manufacturing.

We have never discovered a price list or a box label with the Magna name. The only visual reference to Magna Enterprises is with their name on a Terri Lee Hospital Insurance Plan found on the back cover of the 1960 Terri Lee Magazine with the Days of the Week child and doll on the cover.

At the Salt Lake City 2008 Convention, Sue Nast made a presentation about these other dolls. She brought several examples, most of which were purchased in the red striped Tiny Terri boxes. I recall that prior to this presentation if I found a Littlest Angel doll in a Terri Lee outfit, I would undress the doll in the antique store, walk out with the outfit only and deposit the doll in the trash.

Oh my, the things we learn with more research and knowledge!

What we don't know is whether any of this advertising can be attributed to Magna or whether all of it was from Vi. One can find out the answer to one question and all it does is create more questions! We do know that after the AV fire, Vi made many trips into the courtroom. She tried her best to resurrect Terri Lee and Magna was one step toward that path.

We are quite certain there is more to the story... and we, as collectors, intend to continue the search for more information!

Little Mother Replaces a Ribbon on Terri Lee's Dress

Does one of your Terri Lee's dresses need new ribbons at the waist. Maybe you bought one and it was missing its ribbons. Putting on ribbons is not really that difficult, if you follow the examples of other Terri Lee dresses you may have.

The photos at the right show 2 Terri Lee dresses. The dress with blue trim is sewn on correctly if you compare it to other Terri Lee dresses, the left side laps over the right. The red dress was a question. The ribbon is not like any Terri Lee ribbon I have found and the snaps have been sewn on the wrong side. I wanted both dresses the same so I replaced the red ribbon and sewed the snaps on the correct side.

If you measure the width of the ribbon on a vintage dress you will find it is exactly $\frac{1}{2}$ " wide. I have found $\frac{1}{2}$ " ribbon on eBay also at craft stores, scrapbook stores, and very large fabric outlet stores.

Look for single faced satin ribbon, shiny on one side dull on the other. Some of the new polyester ribbon is very near in look and feel to many of Terri Lee's original ribbons. Terri Lee clothing was made over a long period of time and I feel many different types of ribbons were used, just look at the clothing you have, you might be amazed. I was.

Remove the snaps and old ribbon. Save the ribbon, it might come in handy for a display.

With the dress in front of you, lets' start on the right side.

Fold the cut edge of the ribbon approximately $\frac{1}{2}$ " dull sides together. This will prevent the ribbon from raveling.


Next, place the ribbon on the inside of the right back with the $\frac{1}{2}$ " fold underneath. You will see only dull ribbon.

Then fold the ribbon over the right back and sew the female snap into place as shown in the photo.



Repeat the process on the left back side of the dress except do not fold the ribbon over the back of the dress, simply sew the snap in place as shown in the photo.

Once the snaps are sewn in place, you are done, the new ribbon ties are just like the other dress.



I have been asked many times how can I sew on a snap that looks like the perfectly sewn ones on Terri Lee clothing.

I do have an answer for that question. They are sewn on by machine. There was a special foot you could buy that lets you drop in a snap, adjust it to fit and simply set your sewing machine to zig zag, drop the feed dog and sew into place. What a time saver.



Over the years I have misplaced my snap foot for my old Singer. I can use my button attachment fairly well but would never use it for the vintage clothing as some of the material is fragile and you should hand sew those snaps.

I hope you have enjoyed this little repair tip. I have to admit, I am very fussy about the Terri Lee clothing I have and do want them looking as nice as possible.
